

# Minutes Parish Board Meeting March 3, 2021

The Board meeting began at 7:14pm with Rev Lisa lighting the chalice and reading Amy Schmidt's poem, Abundance, written in memory of Mary Oliver.

<u>Connecting Activity</u>: we recorded a video to support the 2021 Canvass campaign launch on March 7<sup>th</sup>, each member responding to the prompt: What is one thing from FPB that you have been grateful for during the pandemic?

### Let's Talk about Money: compared to what? (Board Goal #1)

Addressing Board Goal #1, Treasurer Margaret Williams shared with Board members a 14-slide presentation about First Parish Finances. The Finance Committee (Margie Beal, Michael Kobran, Steve Pratt-Otto, Charles Sandmel and Margaret) researched how First Parish and five area UU congregations compare in terms of getting and spending money. They are preparing a comprehensive report they will share shortly. The Finance Committee found three ways in which FPB's finances differ significantly from our peers: our building expenses are higher, our income from fundraising is lower, and our draw from endowment is dramatically higher. We draw \$75,000 annually from endowment principal in addition to +/- \$75,000 of interest income.

The Finance Committee described four possible paths forward:	
	The Sustainability Path
	The Do Nothing Path
	The Go Radical Path
	The Blue Sky Path

Board members and Finance Committee members shared both what had surprised them — as well as the ways in which the report confirmed information we already knew or suspected. Members applauded the clarity of the presentation and the insights it revealed. Discussion first focused on possibilities for generating additional income through rentals, pledge increases and fundraising. Margaret urged the Board to give serious consideration to the Finance Committee's proposal to pursue the Sustainability Path. She and others urged us to pursue the path through a framework of "abundance". Members wondered if our questions should focus on "how to get members more deeply engaged and committed." After discussing possible next steps, Janet, Emily, Alfred Margaret and Rev Lisa volunteered to meet before the next Board meeting to explore how to bring the insights from the Finance Committee's to the congregation in ways that lay the foundation for informed and engaging congregational decisions and action in the future.
